Conditions:

1. The children's education act 2009 and Karnataka education act 1983 under this the rules have been enumerated for the registration of schools from the classes explained and renewed (Primary Education/High School Education) 1to 5 1to 8<sup>th</sup>, 6 to 8,9<sup>th</sup> and 10<sup>th</sup> from 1 to 10 exception of the schools additional classes and divisions are not permitted
2. The school under Karnataka Education act 1983 and the rights of children's with regard to the education act 2009 under this the rules have been enumerated under the said rules the school has been to be run
3. The children's rights education act 2009 under this the rules have been enumerated 25% of the seats to be allotted to the children of backward classes is to be reserved. The school comes under the jurisdiction of RTE. The Government reserved seats under the RTE are to be recorded this right is with the organization (the Government with regard to the children's and also the parents those who are residing besides the school. The rules have been enumerated for the goodness of the parents likewise the aid from the government has been received the Educational Institutions the children of the school has to be recorded. If not the private schools situated besides the government schools the particulars of the children's have to be recorded up to the stage. The education to be continued opportunity should be given. These children cannot be differentiated and to continue the education should be provided



4. With regard to the para no.3 the rules explained under RTE the children's admission fee will be released as per the rules, therefore the fees should not be collected from the children and the same is prohibited.
5. School and executive committee of the school should not accept the capitation fees and the payment of donation at the time of admission or after admission should not be received the same is prohibited.
6. School/executive committee, the fees is to be collected from the parents of the children is to be fixed by the government ordinance No ED31PGC2019 Dt 27/07/2019 this information should be released in website and also this information should be published in the notice board and should not collect the additional fees.
7. School/ executive committee the student should be admitted within the specified period of government
8. School/Executive Committee should not reject the documents as per the following conditions
  - (I) Because of the age proof
  - (II) The Admission specified period after the period the admission is requested
9. RTE act and rules Karnataka Education act and according to the rules of the protection procedure and related authorities with regard to the fire department and construction department letter and KSCPCR an NCPCR the education of the children protection
10. School/ Executive Committee as follows:
  - (I) The child who is taking admission in the school the primary and Middle education is to be completed and he should not be retained in the same class and he should not be expelled from the school
  - (II) Any children should not be subjected to the physical and mental activities.
  - (III) The primary education should not be taken any action till the completion and there is no necessity to pass in board examinations



- (IV) Primary education, the child who has completed under RTE rules 21 and Karnataka education act and rules the affidavit will be submitted as per the above act
- (V) RTE act and rules and Karnataka education act and rules, the particular necessities are found those children should be admitted in the schools
- (VI) The appointed teachers under RTE act and rules and Karnataka Education act and rules and the orders from the government with regard to primary and secondary teachers should be qualification of minimum education
- (VII) The salaries to be made to the teachers and necessary conveyance to be paid as per the service rules of Karnataka state and also included with the government notification and provident fund made good through banks paid to the teachers and also the ESI is to be made good
- (VIII) Under the sec 24(1) as per the teachers act, RTE act and rules and Karnataka Education act and rules 17 is noted with regard to the work and supervisory and they should not involve in private tuitions.

11. The lessons were promoted to the school as per the educational authority those lesson books are to be followed
12. Karnataka education act and rules sec 19 as per the available facilities the school has to be admitted the students as per the rules
13. Under sec 19 notified the school rules and the methods are to be adopted as per the Karnataka education act and rules and the employees should be deployed.
14. There should not be conduction of classes within the compound of the school or outside the compound is prohibited.
15. Related to the school the construction and necessary facilities and day or night there should not be any commercial activities and political otherwise education the permission should not be given
16. If any other person or the group of persons should not run the schools for their benefit



17. The accounts of the school should be audited by a chartered accountant that copy should be submitted to the Deputy Director or Block Education Officer every year in the month of June
18. The government notification (Kannada Language procedure 2016) as per the language should be followed in the school
19. RTE act and Karnataka education act and rules the executive committee and teachers are to be administer
20. The school/Executive Committee as per the government rules on the directions of the department are to be followed
21. Every year in the month of march the information of the SATS as per the said rules to be updating is compulsory
22. As per the above conditions if any condition is violated under RTE act 2009 and Karnataka education act 1983 the rules have been enumerated then the approval of the school should be cancelled



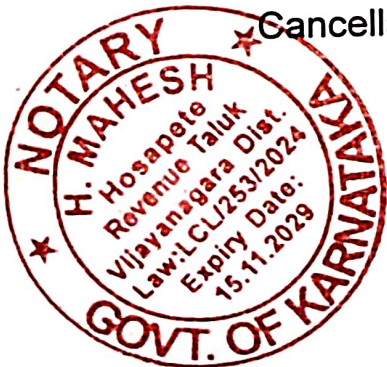
10. Every year medical test should be done as per the Rules.

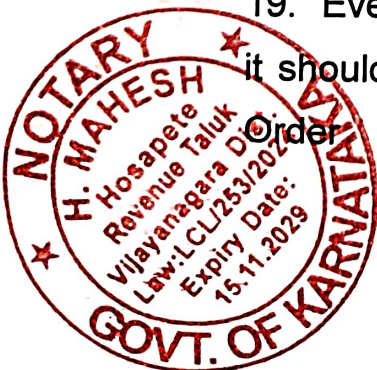
15. Government Notification No.ED369PGC2014 DATED 11-11-2014 and the notification of the Office is dated 11-11-2014 the rules should be followed.

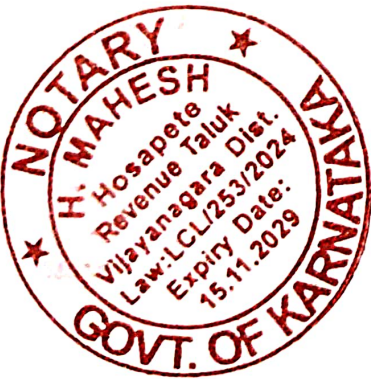

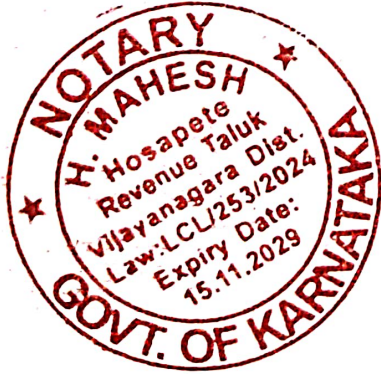
