


- b) Sri H.N. Mohammed Imam Niyazi, S/o late H.N. Fakruddin Sab, shall be the managing trustee and Smt. H.N. Shakeera Begum W/o H.N. Mohammed Imam Niyazi, the Joint Managing Trustee and both shall hold Office for life or till voluntary retirement. In the event of the Office of the Managing Trustee becoming vacant, the Joint Managing Trustee will take over as the Managing Trustee. In the event of the Office of Joint Managing Trustee becoming vacant, remaining trustees may co-opt any one of them as the Joint Managing Trustee.
- c) The other Trustee shall retire by rotation in two at a time, the first to commence three years from the date of the Trust Deed. The retiring Trustees will be eligible to be co-opted for further periods.
- d) The Managing Trustees and the Joint Managing Trustee shall at their discretion co-opt any person / or persons who may be helpful in achieving the objects of the Trust as a Trustee.
- e) The maximum number of Trustees shall not exceed 09 members
- f) A Trustees shall cease to hold Office of Trust on the Trustee becoming insane or lunatic.
- h) The above mentioned two members shall be the Trustees of the Trust, however the Trust can admit any eligible person who possesses the below mentioned qualification :-
- Who has completed the age of 18 years
 - Who is mentally sound.

5) **MANAGEMENT :**

- a) The Management, control of the property and affairs of the Trust aforesaid shall be vested in the Managing Trustee with full powers and authority to purchase or hold any land or hereditament and construct any building for the object of the Trust and any funds or any other properties or investments at any time, subject to the Trust of these presents. It shall be lawful for the Trustees from time to time to frame such rules and regulations for the management and administration of the Trust and charities as they deem fit and to alter or vary the same from time to time to make new rules and regulations provided such rules and regulations shall not be inconsistent with the terms and intents of these presents and not inconsistent with the provisions of Section 2 (15), 11 to 13 and 80-G of the Income-Tax Act, 1961.
- b) The trustees shall meet as often as possible but not less than three times in a year for efficient management of the Trust, to consider the income and expenditure and for disposing of all such other matters as may arise in such meetings.
- c) At all meetings of the both trustee will form quorum. In future if additional Trustee has been to this Trust, then three members will form quorum.
- d) Decision taken by the both Managing Trustee and Joint Managing Trustee will be final, in absence of Joint Managing Trustee, the Managing Trustee can take the decision to safeguard the interest of the Trust and that will not adverse to best interest of the Trust.
- d) At all meetings of Trustees, Managing Trustee or in his absence the Joint Managing Trustee or in their absence any other Trustee shall be the Chairman and all decisions of the Trustee shall be by majority vote, and the Chairman shall have a casting vote in case of equality of votes.

- e) All proceedings of the meeting of the Trustee shall be recorded in a Minutes Book kept for the purpose.
- f) Trustees who fail to attend three consecutive meetings without prior intimation or information shall cease to be Trustees, unless otherwise majority of the other Trustees accord him exception on genuine and valid grounds.
- g) In case of any difference of opinion between the Trustees in any matter connected with the trust and its administration the decision of the majority will be final and binding on all the Trustees.
- 6) **POWER OF TRUSTEES :**
- a) The Managing Trustee shall manage Trust Funds and collect and recover the interest, income and profits thereof and to pay thereout the expenses of collection and other outgoing, if any.
- b) The Managing Trustee shall have all powers specifically conferred to do things as may be required for the proper conduct of the Trust and in the interest of the Trust, whenever, such powers are not specifically conferred.
- c) The Managing Trustee shall be entitled from time to time to open, maintain and operate a Bank Account or accounts in the name of the Trust or in the name of the School or Schools or Institutions as such Bank or Banks as they may from time to time decide and may at any time pay or cause to be paid any monies forming part of the Trust Fund / School Fund or the income thereof to the credit of any such accounts either by way of Fixed or Current Account or any other account. Any such account shall be operated open individually by Managing Trustee or Joint Managing Trustee or by any two of the other Trustees.
- d) The Managing Trustee shall have powers to maintain and defend all such suits as well as other proceedings and filing of complaints, submission

e) The Trustees are bound by all the liabilities cast upon them under the Indian Trust Act 1882 except to the extent of the powers specifically conferred under these presents.

f) The Managing Trustee at his discretion may sell immovable property or properties which may for the time being the subject of the Trust of these presents, with power to buy and sell the same without being responsible for any loss that may thereby be incurred and in case of such sale, to extent and do all such deeds and acts for the purpose of carrying such sales into effect as the Trustees may think necessary and all monies occurring from any such sale shall be deemed to be part of the Trust Estate and shall be applied accordingly.

g) The Managing Trustee may at any time receive voluntary contributions from any person or persons by donation, legacy, gift, annual or monthly subscription and also can receive Government and other grants for the benefit of the Trust. The Trustees shall apply such contribution in accordance with the objects of the Trust.

h) Proper accounts showing all receipts and disbursements made on account of the Trust hereby constituted shall be kept by the Trustees who shall prepare Receipts and Payment Account, Income and Expenditure Account and Balance Sheet as on April 30 every year and shall be duly audited by a qualified Chartered Accountant.
