

- j) The Managing Trustee shall have power to raise or borrow for the purpose of Trust from time to time in the name of the Trust or otherwise on behalf of the Trust such sums of money as they may from time to time deem expedient either on the mortgage of the whole or any part of the property of the Trust, or by bonds, debentures, deposit receipts, promissory notes, with or without security or in such other manner as they may consider proper.
- All the funds of the Trust shall be deals with under Section 13 of the Income-Tax Act of 1961.
- 7) In the event of the dissolution or the winding up of the Trust the assets remaining on the dissolution shall be transferred to other Trust, Society or Institution whose objects are similar to those of this Trust and that in no event shall the assets so remaining be distributed among the Trustees.
