	9	The school shall submit an undertaking with regard to uploading all requisite information regarding students, teachers and infrastructure available in the school on the UDISE Portal. The registration of the students in classes IX and XI shall be conditional on the school providing complete information on UDISE.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal.
